SOCIAL WELFARE SERVICES

ASSISTANCE TO INDIVIDUALS IN CRISIS SITUATION (AICS)

<u>About the Service</u>: MSWDO caters to disadvantaged individuals or families needing emergency assistance on case to case basis.

Requirements: For Medical Assistance:

- 1. Clinical Abstract/Medical Certificate with signature and license number of the attending physician (issued within 3 months)
- 2. Hospital bill (for payment of hospital bill) or prescription (for medicines) or

laboratory requests (for procedures)

- 3. Barangay certification of residency or indigency of the client
- 4. Referral letter (if applicable)

Note: Does not cover room and board and Doctor's Professional Fee

For Burial Assistance:

- 1. Funeral Contract
- 2. Death certificate duly certified by the Local Civil Registrar
- 3. Barangay certification of residency or indigency of the client
- 4. Referral letter (if applicable)

For Transportation Assistance:

- 1. Barangay certification of residency or indigency of the client
- 2. Police blotter (only for victims of abuse and other similar circumstances)
- 3. Referral letter (if applicable)

For Educational assistance:

- 1. Enrollment Assessment Form or Certificate of Enrollment or Registration
- 2. School billing duly certified by the billing clerk
- 3. School ID of the student/beneficiary
- 4. Barangay certification of residency or indigency of the client
- 5. Referral letter (if applicable)

For Burial Assistance - Death Certificate duly certified by

For Educational Assistance - Enrollment Assessment Form

or Certificate of Enrollment or

Registration

For Assistive Device – Barangay certification of residency or indigency of the client and medical abstract/certificate

SECURING A SENIOR CITIZEN, PERSON WITH DISABILITY AND SOLO PARENT'S IDENTIFICATION CARD

About the service: Senior Citizens (60 years old and above) can secure an OSCA I.D. to avail the benefits and privileges as stipulated in R.A 9275 or known as the "Expanded Senior Citizens' Act."

Persons with Disability (PWDs) can avail the benefits and privileges stipulated in R.A 9442 or known as the "Magna Carta for Disabled Persons and for other Purposes" when securing an ID.

A Solo parent can avail the benefits under R.A 8972 "An Act Providing for the Benefits and Privileges to Solo Parents and their Children", Appropriating Funds therefore and for other purposes known as "Solo Parent's Welfare Act of 2000".

Requirements:

For Senior Citizen

- 1. Accomplished Registration Form
- 2. Birth certificate/baptismal certificate or any documents that would support his/her birth date
- 3. 2 pcs 1 x 1 picture

For Person with Disability

- 1. Clinical abstract/Medical certificate reflecting his/her disability
- 2. Accomplished registration form
- 3. 2 pcs 1 x 1 picture

For Solo Parent

- 1. Accomplished application form
- 2. Barangay certification that the applicant is a resident of the said barangay for at least six months.
- 3. Appropriate documentation/evidence that applicant is a solo parent (ex. death certificate of spouse, etc.)
- 4. 2 pcs 1 x 1 picture

ASSISTING PERSONS WITH DISABILITY (PWDs)

About the Service: This provide the client/s assistance to avail of assistive devices, skills training and livelihood opportunities and therapy services for referral.

Requirements:

- Assistive Devices whole body picture, letter of intent by the client, clinical abstract/medical certificate, barangay certificate of indigency or residency
- Skills Training services/ Vocational Rehabilitation (AVRC) whole body picture, letter of intent by the client, clinical abstract/medical certificate, X-Ray result, barangay certificate of indigency, Birth Certificate (Xerox copy), 1 x 1 picture
- ➤ Referral to therapy services at STAC (Stimulation and Therapeutic Activity Center) Whole body picture, clinical abstract/medical certificate, barangay certificate of indigency and residency, birth certificate (Xerox copy).
